

#### PRO-BUSINESS GOVERNMENT

Florida is a Right-to-Work state and is consistently ranked one of the best for business due to its stable leadership and favorable corporate tax policies. Locally, collaboration between government and industry has resulted in effective development practices, expedited permitting, and a streamlined regulatory process.

#### AFFORDABILITY

Tampa Bay is one of the most cost competitive places to do business in the nation. Companies here enjoy low labor costs and a low tax operating environment, with an average local sales tax around seven percent, a state corporate income tax of only 5.5 percent, and no personal income tax.

#### INCENTIVES

Targeted, performancebased financial incentives for qualifying projects can lower the barriers to market entry and mitigate the cost of relocation and expansion. We'll work with you to access these resources, as well as workforce training grants, tax exemption programs, and more.

# SMART GROWTH FOR A SUSTAINABLE FUTURE

Tampa Bay is in the midst of a historic transformation that will shape the economic future of the region. One of the highest profile projects underway in Tampa is the redevelopment of 50 acres along the downtown waterfront. A real estate development joint venture between Bill Gates' Cascade Investment, LLC, and Jeff Vinik, owner of the Tampa Bay Lightning, is creating a mixed-use development in the heart of the urban core that will be **the world's first WELL Certified™ city district for wellness** known as Water Street Tampa. The district will offer more than 1 million sq ft of new retail, educational, and entertainment spaces. Along with new hotels, residences, and office space, the USF Health Medical School will open in Water Street at the end of 2019.

The **Connected City** is a 7,800-acre mixed-use community that will be the first Smart Gigabit Community in the nation to be built from the ground up with a fiber network providing exclusive ULTRAFi internet technology ranging from 1Gbps to 10Gbps. Envisioned by Metro Development Group, the community will also be powered by renewable energy and have over 100 miles of designated autonomous vehicle lanes. The site will include a high-tech education center, a wellness campus with advanced research facilities, an innovation center, a medical hospital with med-spa, as well as a health and performance institute. The two master-planned communities will feature two 7-12 acre MetroLagoons by Crystal Lagoons.

# PORT TAMPA BAY

Port Tampa Bay is the largest seaport in Florida in terms of tonnage and geographic area. The Port handles over 34 million tonnages spread over 5,000 acres. Port Tampa Bay is home to six cruise ships and 400,000 passengers boarded ships at Port Tampa Bay terminals.

Port Tampa Bay is the nation's closest deep water gateway to the Panama Canal and an unparalleled point of connection to Latin America.

The new Tampa Gateway Rail Terminal extends Port Tampa Bay's reach to the Midwest, Northeast, and other national destinations through the CSX Rail Network. Large tracts of property with exceptional deep water, highway, and rail access are also zoned and available for immediate manufacturing and industrial development.



# **INTERNATIONAL AIRPORTS**

**Tampa International Airport (TPA),** located just 15 minutes from Tampa's downtown business district, is one of the most convenient and efficient airports in the country for business travel. Recognized as the #1 airport in the US by *Condé Nast Traveller* and *Travel & Leisure* magazines, TPA provides global access to over 21 million passengers each year. It also offers nonstop access to major cities worldwide, with 300 daily departures to 93 non-stop domestic and international destinations, as well as world-class corporate aviation services with separate customs and border protection facilities.

**St. Pete-Clearwater Airport** offers 60 non-stop destinations and flew over two million passengers in 2022. The airport generates over 3.4 billion dollars in total economic impact to the metro area.

The Tampa Bay / Orlando, I-4 Corridor, super region is home to over 8 million people and welcomes over 60 million tourist visitors per year, making it a huge consumer market. Major export markets include Mexico, Canada, and India; however, Tampa Bay companies export their products and services to many markets throughout the world with easy access and close proximity to Latin America and the Caribbean.
